NOTICE INVITING TENDER

Director, Atomic Minerals Directorate for Exploration and Research (AMD), Begumpet, Hyderabad, on behalf of the President of India, invites sealed bids in three parts (Pre-qualification, Techno-commercial and Price) from eligible bidders, for carrying out following work.

- Cost of Tender documents is Rs.1500/- (Rupees One thousand and Five hundred only) payable in the form of non-refundable crossed Demand Draft, drawn on any nationalized/scheduled bank in favour of the Pay and Accounts Officer, AMD payable at Secunderabad.
- The Request for Proposal in three volumes gives complete work description, specifications, and terms and conditions. The individual volumes are organized as follows:
 - Volume I : Technical and Functional Requirements
 - Volume II: Commercial and Bidding Terms
 - Volume III: Draft contractual terms and Service Level Agreement

Any other form of payment is not accepted.
- Along with the cost of tender document, bidders shall enclose a dully filled, signed and stamped Non-Disclosure Agreement (NDA) in original in the format that is available on the website www.amd.gov.in.
- E.M.D. is to be submitted in the form of crossed D.D./Pay Order from any Schedule Bank drawn in favour of **Pay and Accounts Officer, AMD Payable at Secunderabad**. 50% of EMD will be accepted in the form of Bank Guarantee if intended. Non fulfillment of requirements of Letter of Award of the successful bidder and non commencement of the work after issue of work order shall lead to forfeiture of full amount of EMD to Government.
- Each of the three bids and E.M.D. are to be enclosed in separate sealed envelopes marked respectively on the cover with "Tender No. **AMD/AMDC/EGDMS/2014-15/1**". All the four envelopes shall then be placed in another sealed envelope superscribing the tender No. & date and submitted.
- **A document describing broad processes of the AMD and also list of data formats and types of data generated by AMD during exploration will be made available to those bidders who purchase the tender document, only within the premises of AMD (including its Regional Offices). The bidders shall have to go through the document and make note of essential information that are important to them. No copying, photocopying of the document will be allowed. The addresses of the AMD Regional Offices are available at www.amd.gov.in**

- The Bidder / Agency on whom the letter of Intent will be issued shall have to submit Police Verification Certificate issued by local Police Authorities for himself/Engineers/Supervisors as per existing security rules of this Directorate for allowing them to execute the work.
- The tender shall be valid for Eight Months from the last date of submission of Bids.

- Director, AMD, Hyderabad reserves the right to accept/reject any or all tenders without assigning any reason thereof. Tender with any condition including conditional rebate, shall be rejected forthwith. (Please also visit our website <http://www.amd.gov.in>)

Pre-qualification Criteria:

The following are the mandatory pre-qualifications criteria. The bidder should fulfill these criteria in order to qualify in the pre-qualification evaluation process.

- a. The bidder must be a **legally registered company in India** as per the Companies Act of 1956 with office and operations in India for at least the **last five financial years**. The bidder will be a single legal entity and shall **not** be a joint venture or a consortium of firms. The bidder shall also certify that only **Indian Nationals** will work on the given project.
- b. The bidder should be a profitable company for the last three years and must have an **average annual turnover** of not less than **Rs. 50 crore** for the last **three consecutive financial years**.
 - a. Out of the total turnover of the company, at least **Rs. 5 crore** or above per year should be from **Geospatial services** for the last three financial years.
 - b. Out of the total turnover of the company, at least **Rs. 5 crore** or above per year should be from **IT services** for the last three financial years.

A certificate in this regard shall be submitted by a registered Chartered Accountant / Auditor.

- c. The bidder must have experience of successful end-to-end implementation of Geospatial and IT solution during the last 5 years ending last day of the month previous to the one in which bids are invited. The bidder should also satisfy at least one of the following three criteria of project completion.

1. Three projects comprising of complete life-cycle implementation of Geospatial \

application (including software, hardware and maintenance) costing not less than

40% of total estimated project cost each (OR)

2. Two projects comprising of complete life-cycle implementation of Geospatial application (including software, hardware and maintenance) costing not less than

60% of total estimated project cost each (OR)

3. One project comprising of complete life-cycle implementation of Geospatial application (including software, hardware and maintenance) costing not less than 80% of total estimated project cost.

The value of the work carried out during last 5 years shall be updated based on simple interest formula @7% per annum to arrive at present cost.

- d. The bidder should have a solvency of Rs. 260 Lakhs (Rs Two hundred and sixty Lakhs only) certified by his Banker(s). The solvency certificate shall be obtained from any scheduled bank within one year which shall be reckoned from the last date of submission of tender (ie the certificate shall be issued on or after 30-12-2013).
- e. The bidder must have a team of at least 100 IT personnel on its rolls having experience in implementing IT applications; of these at least 25 should be experienced in Geospatial database. In addition the bidder must also have at least 10 professionals trained in RDBMS, and System Software.
